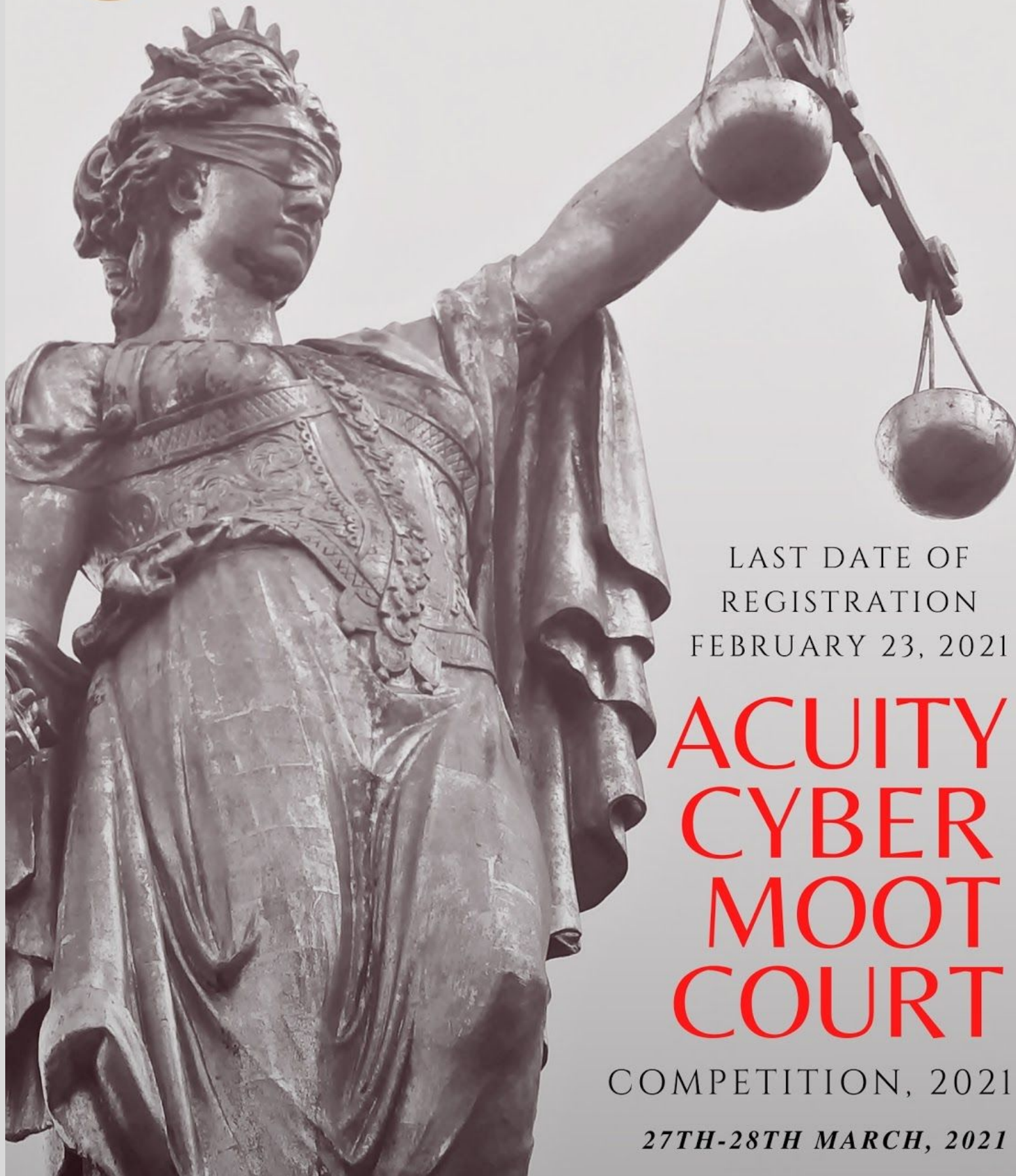

The theme of the Moot Court Competition will be based on Cyber Laws. In the present times, it is imperative to understand and know about the basics of the cyber domain for everyone and very essential for law students to understand the intricacies of the Cyber Laws. Cyber Laws are important as they revolve around all the transactions and activities over cyberspace. Every action and reaction in cyberspace has some legal and cyber legal angles.



## **RULES, PROCEDURE AND GUIDELINES OF THE COMPETITION**

### **I. DEFINITIONS**

The following terms shall have the corresponding meanings unless otherwise specified:

I.1. 'Competition' shall refer to Acuity Cyber Moot Court Competition, 2020.

I.2. 'Competition Problem' shall refer to the facts and issues released by the organizers of the Competition with its clarifications and corrections.

I.3. 'Competition Rules' shall refer to the official rules of the Competition as amended from time to time.

I.4. 'IST' shall refer to Indian Standard Time.

I.5. 'INR' shall refer to Indian Rupee.

I.6. 'Knock-out round' shall refer to the Quarter-finals, the Semi-finals and Final rounds of the Competition.

I.7. 'Memorial' shall refer to the memorandum of written submissions submitted by any participating team as per the Competition Rules.

I.8. 'Organizing Committee' (hereinafter to be referred as O.C.) shall refer to the committee appointed for the administration and conduct of the Competition including any other authorized persons, and of all events leading up to the Competition.

I.9. 'Official Email' shall refer to the official email id of the World Cyber Security Forum ([cybermootcourt@gmail.com](mailto:cybermootcourt@gmail.com))



## **II. GENERAL RULES**

### **a. Eligibility**

II.a.1. All recognized law schools, universities and institutions in India with a minimum three year of LL.B. courses shall be eligible to participate.

II.a.2. Each participating team shall comprise a minimum of two (2) members and maximum of three (3), wherein two (2) members, shall be designated as Speakers and one (1) member as Researcher (optional).

II.a.3. No team shall contradict the composition mentioned above. No faculty member, coach, or a designated observer will be allowed to join the video-conferencing or chat room during the session.

II.a.4. The language of the competition will be English.

### **b. Dress code**

The dress code for the participants shall be formals.

Men are expected to wear Western Formals only (Black Blazer, Black Pants, White Shirt, and Black formal shoes).

Women can wear Western Formals (Black Blazer, Black Pants, White Shirt, and Black formal shoes).

### **c. Registration**

1. Teams are supposed to complete their registration by 23<sup>th</sup> February, 2021.

2. Registration fee for the competition is INR 1199 per team.



3. Interested teams may fill out the application form by way of the Google form. The link of the Google form is: <https://forms.gle/CzmqTmGJRHc9RXjQ7>
4. Upon confirmation, every team would be given a 24 hours period to transfer the registration fee of INR 1199 per team. The payment details shall be sent through mail.
5. The last date to pay for registration fee is 24<sup>th</sup> February, 2021.
6. After the payment has been made by the team, a screenshot depicting payment confirmation with transaction ID must be sent to [cybermootcourt@gmail.com](mailto:cybermootcourt@gmail.com). The payment will be confirmed after the details have been shared and verified.
7. Final registration of the teams is subject to the successful payment of the registration fee within the stipulated time.
8. There shall be no refund of the registration fee under any circumstance, unless the competition is called off.
9. Final decision on any issue shall be of the organising committee.
10. By applying for the competition, the teams shall be deemed to have accepted the rules, terms and conditions as stated in this document.

#### **d. Memorandum**

- II.d.1. Each Team participating in the Competition must prepare a memorandum on behalf of the Prosecutor/Applicant and on the behalf of the Defendant/Respondent.



II.d.2. Each team must send its memorandum via e-mail to the O.C. at [cybermootcourt@gmail.com](mailto:cybermootcourt@gmail.com) latest by 14th March , 2021 by 23:59 hours IST. Please note that NO HARD COPIES ARE TO BE SUBMITTED.

II.d.3. Any memorial submitted after the deadline shall be subject to penalty for late submission.

II.c.4. The Memorial must contain the following parts only:

*Format Specifications*

1. Each Team is required to prepare a memorial for each party of the dispute with the following mandatory heads:
  - i. Cover Page
  - ii. Table of Contents
  - iii. Index of Authorities
  - iv. Statement of Jurisdiction
  - v. Statement of Facts (Must Not Exceed 2 Pages)
  - vi. Issues Raised
  - vii. Summary of Arguments (Must Not Exceed 2 Pages)
  - viii. Arguments Advanced (Must Not Exceed 25 Pages)
  - ix. Prayer (Must Not Exceed 1 Page)



2. The Cover Page must contain only the following information:
  - i. The Team Code in the upper right corner of each memorial. No other.
  - ii. The page must contain the team code.
  - iii. The name of the Forum resolving the dispute.
  - iv. The name of the Competition.
  - v. The jurisdiction under which they are approaching the court/tribunal.
  - vi. Name of the parties and status before the Forum.
  - vii. The party on whose behalf the memorial has been prepared
3. All parts of the memorial (including headers, footers and headings) must be typed on A4 sized paper/format, with the following Formatting Specifications:
  - i. Page Orientation: Portrait
  - ii. Font Type: Times New Romam
  - iii. Font Size: 12
  - iv. Line Spacing: 1.5
  - v. Margins: One (1) Inch on Each Side
4. For Footnotes, the Formatting Specifications are as below:
  - i. 20th Edition Bluebook style of uniform footnoting must be followed throughout the memorials.





- ii. Font Type: Times New Roman
- iii. Font Size: 10
- iv. Line Spacing: 1
- v. Speaking footnotes or endnotes are not allowed.

### **III. STRUCTURE OF THE COMPETITION**

The Competition shall consist of four Rounds:

- a. The Preliminary Round;
- b. The Quarter Finals
- c. The Semi Finals; and
- d. The Final.

#### **a. Preliminary Round - Individual Round**

In the preliminary rounds, participants will have to send their pre-recorded video to the official email ID. Each speaker shall be allowed a maximum of 7 minutes to present their pleadings. The teams shall send the recorded pleadings on behalf of the Prosecutor/Applicant and on behalf of the Defendant/Respondent. Last date of submission of the pre-recorded video is 20<sup>th</sup> March by 23:00 hours IST.

Note: Video should be recorded at once, no editing (cut-mix of two slides) should be done. It should be recorded in proper formal uniform. The announcement of results of preliminary rounds will take place on 23<sup>rd</sup> March, 2021. The decision of the judges would be final and would not be questioned or changed in any circumstances.



**b. Quarter- Finals Round Virtual E-Moot**

The Quarter-Finals would be conducted on 27<sup>th</sup> March, 2021 via video-conferencing. The Quarter-final round of competition consists of sixty (60) minutes of oral pleadings including rebuttals. Prosecutor and Defendant are each allotted thirty (30) minutes. A maximum of five minutes shall be reserved for rebuttals and sur-rebuttals.

**c. Semi-Final Round- Virtual E-Moot**

The Semi-Finals would be conducted on 27<sup>th</sup> March, 2021 via video-conferencing. The semi-final round of competition consists of eighty (80) minutes of oral pleadings including rebuttals. Prosecutor and Defendant are each allotted forty (40) minutes. A maximum of five minutes shall be reserved for rebuttals and sur-rebuttals.

**d. Final Round- Virtual E-Moot**

The Final Round of competition will be conducted on 21<sup>st</sup> March, 2021 consists of one hundred (100) minutes of oral pleadings including rebuttals. Prosecutor and Defendant are each allotted fifty (50) minutes. A maximum of five minutes shall be reserved for rebuttals and sur-rebuttals.

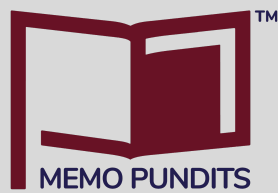
## **IX. MISCELLANEOUS**
