The University has received email communication dated 16.10.2015 from Inside Process Specialist - SMB&D - Licensing & Compliances, Bertelsmann Marketing Services managing Microsoft Licenses and support Anti-Piracy team at Microsoft India. Vide the email it has been informed that the Microsoft product usage at Hidayatullah National Law University is higher than what it is licensed for and the Microsoft wishes to set this matter right. After collecting the relevant information from HNLU, M/s. Microsoft Business, Redington India Limited vide email dated 07.12.2015, has informed that the Hidayatullah National Law University needs to procure licenses from any of the below options to comply with the Microsoft licensing requirements:-

Subject to the following terms and conditions:-

- 1. The University will procure licenses as per FTE (which is around 100 for HNLU) and are allowed certain licenses to be used campus wide.
- 2. The University would still need to procure the base OS licenses
- 3. As a part of the Edu-cloud, HNLU would additionally get the following Office 365 (Email, Skype, One drive, Share point, Office Apps) for faculty + Office 365 free for all students.

#### SI. Particulars

As informally informed by the representatives of M/s. Microsoft India, the above Option 1 will cost approximately Rs.30.00 Lacs (Rupees Thirty Lacs) on One Time basis. But, the Microsoft products purchased through Option-1 cannot be upgraded as per future requirements. And the above Option 2 will cost Rs.15.00 Lacs (Rupees Fifteen Lacs) for the first year and thereafter, it will require regular subscription of Rs.5.00 Lacs (Rupees Five Lacs) per year. This will enable regular upgradation of the Microsoft products purchased through Option-2.

For complying with licensing requirements and to avoid any untoward legal consequences, as informed by M/s. Microsoft India, the University needs to go for immediate payment and procurement of the required licenses from amongst the above two options from its authorized vendors since the company does not directly sell the licenses. Since, the payment has to be made immediately, tender process in the instant case is not possible and hence it is proposed to procure the required licences from its authorized vendors by way of quotations. The University proposes to go for Option 2 costing Rs.15.00 Lacs (Rupees Fifteen Lacs) for the first year and thereafter, for regular subscription of Rs.5.00 Lacs (Rupees Five Lacs) per year.

Accordingly, the matter is placed before the Finance Committee of the University for perusal and approval of Rs.15.00 Lacs (Rupees Fifteen Lacs) for immediately purchasing/procuring the required Microsoft licenses by way of Option-2 from the authorized vendors of M/s. Microsoft by way of obtaining quotations from them, so as to comply with the legal licensing requirements.

Since it is a legal requirement and immediate payment is required to be made, therefore, ex-post facto approval of the Executive Council may be obtained as and when it meets next.

# 3. Construction of Vice-Chancellor's Bungalow and other allied works.

The Executive Council of the University in its meeting dated 14.12.2013, has approved construction of Vice-Chancellor's Bungalow and other allied works from M/s. NCC Limited for the estimated value of Rs.3.37 Crores (Rupees Three Crores Thirty Seven Lacs) in totality (and not in parts/reduced quantum) as per the firm's letter dated August 31, 2012.
