NOTE ON ACADEMIC PROGRAMME OF YEAR 2020-21 FOR STUDENTS OF 2ND TO 5TH <u>YEARS</u>

1.The Academic programme for the year 2020-21 starts from August 17, 2020 by digital mode and shall continue till the reopening of the physical classes at campus as per the direction of the Ministry of Education/ UGC and BCI.

2. The classes scheduled as per time table (**Annexure-I**) will be by a Flexi-Teaching-Learning (FTL) mode of uploading the sessions a day prior to the classes in the WebEx cloud to be downloaded by the students.

3. The FTL mode is supplemented by the Live Interaction Sessions (LIS) where in the students of each section of each year of study can log in at designated times (time table in **Annexure II**) to interact on questions/clarifications and interaction with the subject teacher in WebEx Platform. The guidelines for the LIS (**Annexure III**)

4. The subject teachers will be supplementing in the lecture material and separately the required reading materials to be perused which could include scanned articles/ web links/ materials that can be accessed by remote access data bases.

5. The notification of Fee structure/ time line for payment will be announced by 25^{th} of August 2020.

6. The scheme for the pending final examination of April 2020 for the continuing students to be announced based on the advisory of the UGC/BCI.

7. The Note on the revised evaluation method of internals/midterm and final year exam to be announced on 1^{st} of September 2020.

8. The University is preparing the schedule for the new SBA via online mode and will be announcing the same by 1^{st} of September 2020. Till that time students can send in their requests and feedback through their respective class representatives.

GUIDELINES FOR LIVE INTERACTIVE SESSION (LIS)

- 6. This LIS is voluntary, and the students have the option of only choosing the mail mode to clarify the doubts if they wish.
