**3. Review of the building construction - perusal and decision.**

**(a) Payment to NCCL**

**Notes:**

- (i) The University has paid Rs. Rs.1,96,14,771/- (Rupees One Crore Ninety Six Lacs Fourteen Thousand Seven Hundred and Seventy One) against R.A. Bill No.16 (Revised), R.A. Bill No. 17 (Civil work) and R.A. Bill No. 18 (Civil Work) to M/s. NCCL, Hyderabad on approval and certification of Principal Secretary P.W.D. Mr. M.K. Raut/Chief Engineer P.W.D. under the impression that the Executive Council has authorized Principal Secretary P.W.D. for all endeavours and on his certification the University has to make payments without any further scrutiny of bills or work of NCCL. However, minutes of the Executive Council subsequently finalized by Hon'ble Justice S.B. Sinha are different in this regard.

**Hence the above bills certified by P.W.D. and payments made are placed before the Executive Council for ex-post-facto approval.**

- (ii) Vide University letter dated 01.05.2009, in view of the decisions of the Executive Council meeting dated 21.06.2008 & 09.03.2009, guidance/consent/ approval of Hon'ble Executive Council members was sought by circulation of papers as per Statute 10(6) of the HINUL Act, 2003 for payment of R.A. Bill No.019 & Escalation Bill No.6. Further, as per communication dated 07.05.2009 received from office of Hon'ble Lordship, papers pertaining to R.A. Bill No. 019 and Escalation Bill No.6 were circulated to the members of the Executive Council vide University letter dated 11.05.2009 and 25.05.2009. But so far the University has not received approval from the members of the Executive Council in this regard.

It is worth mentioning that the Executive Council of the University in its meeting dated 08.01.2009 had constituted a Committee of Vice-Chancellor HNLU, Advocate General

Chhattisgarh, Principal Secretary P.W.D., Secretary Law Department, Secretary Finance Department and Secretary Higher Education Department Govt. of C.G. to discuss and decide all issues related to construction of HNLU buildings and submit its report. The committee met on 12.01.2009 and 21.02.2009 and deliberated in detail the issue of construction and submitted its report dated 03.03.2009. (Copies enclosed as Annexure 3, 3(a) & 3(b) Page Nos.11-13). It is worth mentioning that in spite of the detailed deliberations of the meeting dated 12.01.2009 and 21.02.2009 of the Committee, there are vast deviations in the construction work on the issues of Architectural support, provision of lifts, escalation charges etc. Copy of letter No.11NLU/7432/2009 dated 16.01.2009 (alongwith 20 Annexures in 146 pages) sent to P.W.D. under copy to Principal Secretary P.W.D. is enclosed for perusal in this regard (Annexure No.15, Page Nos.174-322)

The Executive Council of HNLU in its meeting dated 09.03.2009 on agenda item No.3 has decided that Shri M.K. Raut, Principal Secretary P.W.D., Govt. of C.G. shall supervise, control and make all endeavours to get the construction work completed by 30.06.2009. In view of this decision of the Executive Council we are of the view that the project should be taken up by P.W.D. as deposit work and P.W.D. is expected to go through the documents thoroughly and take care of the interest of HNLU.

Else

The Executive Council may constitute a committee from its following ex-officio members i.e. Principal Secretary Law, Principal Secretary Higher Education and Secretary Finance Department to take care of the construction work and interests of HNLU. They may also be made the D.D.O. for the construction work.

**The matter is placed before the Executive Council for decision on further course of action.**

- (b) Construction of Internal Roads, Boundary Wall and Gate as deposit work – Two proposals received are placed for perusal and decision.

The University has received proposals for construction of internal roads, boundary wall and gate by way of deposit work from C.G. P.W.D. and C.G. Housing Board.

**Notes:**

University Grants Commission vide letter No.F.6-2/2009 (Comp./Tech.) has granted approval and released grant-in-aid to HNLU for establishment of Computer Centre during the XI plan. As per the terms of sanction, UGC has approved the following posts for the XI Plan period:

1. System Analyst (01) - pay scale of 12000-420-18300
2. Technical Assistant (01) - pay scale of Technical Assistant/Assistant as per University norms (i.e. 5500-175-9000 A.G. I).
3. Personal Assistant (01) - pay scale as prescribed by University for similar position (i.e. 6500-200-10500)

The salary of the above staff supported by the UGC will be assisted as per actual; for the plan period beginning from the year in which the system has been installed or from the year in which the first post has been filled up, whichever is later. After Plan period ceases, it shall be the responsibility of the University Management/State Government to continue the posts and to this extent, concerned authorities will have to submit the undertaking to UGC (Annexure No.16, Page Nos.323-330).

Earlier, similar request was made to State Government to bear the expenditure of posts sanctioned by UGC but the same was rejected by State Government.

**The matter is therefore placed before the Executive Council for creation of the above posts at HNLU. The payment of salary for these posts sanctioned by UGC for the plan period that i.e. upto 2012 shall be borne by UGC as per actuals.**

The Executive Council in its meeting dated 08.01.2009 constituted a Committee of Vice-Chancellor HNIU, Advocate General Chhattisgarh, Principal Secretary P.W.D., Secretary Law Department, Secretary Finance Department and Secretary Higher Education Department Govt. of C.G. to convene a meeting to discuss and decide all issues related to construction of HNIU buildings. The above committee met on 12.01.2009 at 5.30 p.m. wherein the following members were present:


The Committee constituted by the E.C. discussed the issue of completion of construction project. It was found that NCC has almost stopped the work of construction since 31.07.2008. the date upto which they were granted extension by the then University Engineer-in-Charge Mr. S.C. Deshpande. They have neither applied nor granted further extension of time. They have always insisted for payments even if a single bill is pending before the University.


The construction company representatives were called by the committee to clarify their position. They have claimed that a number of bills are pending, a number of decisions related to construction are pending and without payment of any pending bill they will not be able to work. It was found that pending decisions were due to non-availability of architect of NCC who has not visited the site since long. NCC was instructed to call their architect. The representatives of NCC promised to call their architect Mr. Amit Sharma on or before 20.01.2009. They have informed that in case all the payments are made and all the decisions are made available, they will be able to complete the girls hostels, main building and staff quarters within a period of 4 months; training centre, directors bungalows, V.C. bungalow and class IV employees staff quarters within a period of 6-8 months.


The committee has found that hardly one bill is pending for payment for which they were given extension of time. Two more bills are submitted for which extended time period has elapsed.


The committee has instructed P.W.D. technical staff Shri D.K. Pradhan, S.E. and Shri N.K. Jayant, E.E. to assess the actual work performed on the site, its cost and payments made till date so that the decision may be taken to ascertain whether we have released excess payments or only payments for work. This is also required for assessment of the claims of NCC that whether they have worked more and received less payment and whether there is any possibility of expediting completion of construction work well within the time limit. The committee discussed that as far as performance of the construction company is concerned it has taken more than 52 months against stipulated time period of 14 months, but till date not a single building has been completed.

After getting all the facts from different sources, the committee will meet once again in near future.





The committee has unanimously shown concern for the completion of the project. The attitude of NCC was found negative since last two years. The committee is in favour of recommending termination of the building contract with NCC but before going for such decision, the committee is of the view that if possible all the issues may be settled in between HNLU & NCCL with the help of Shri M.K. Raut, Principal Secretary, P.W.D., Govt. of Chhattisgarh and to complete the entire project in 3-4 months by all means (not in piccemeal) and releasing the payment only afterwards.


In such case HNLU will provide NCCL extension of time with penalty and without escalation. There will not be any payment for extra items if not agreed/not approved in writing specific extra items with cost. The NCCL will also have to carry out corrections in defective construction. For all this, there is need of signing MoU as a part of contract agreement in between HNLU & NCCL.

The committee is of the view that the issue of technical and financial sanction to the project may be decided by the Principal Secretary P.W.D. *in terms of presently effective rules, instructions, directions of P.W.D.*

**REPORT OF THE COMMITTEE CONSTITUTED BY THE EXECUTIVE  
COUNCIL**

**Dt. 03.03.2009**

The committee consisting of Vice Chancellor, HNLU, Advocate General, Chhattisgarh, Principal Secretary (PWD), Secretary (Law), Principal Secretary (Higher Education), and Secretary (Finance), Government of Chhattisgarh has convened its meetings on 12<sup>th</sup> January and 21<sup>st</sup> February, 2009.


The committee has gone through all the details, assessed the progress of construction work and discussed on the issues with M/s. NCCL.


The findings of the committee are as under:


- a. The committee has found that the attitude of the construction company M/s. NCCL has been entirely negative and blunt. They have slowed down the pace of the work and stopped the work since last one and half years, and six months respectively.
- b. They have made so many promises to complete the project but never complied. They have delayed the project and charged escalation.
- c. The company has submitted bills even for the work not performed; such amount was deducted by the Engineering Staff of HNLU from the bills. A number of constructions were found defective and no rectification was made even after giving them notice. They are claiming payment for extra-items without proper permission or order of University authorities.
- d. It is difficult to believe that M/s. NCCL is willing to work or will be able to complete the project.


Based on the above facts, the committee is forced to recommend as under:

1. The University may terminate the contract within the norms of the contract agreement.
2. The University may take over executed/unexecuted construction work to give it to any other construction agency at the risk and cost of NCCL as per the terms of contract agreement.







**I, in all my sincerity, request your good office to condone/waive the notice period stipulated in the Staff Regulation.** I am hopeful that your good office will exercise this discretion in consideration of the relentless contributions (both academic and administrative) made by me during my services to the University. It is a matter of fact that I have always confronted the situation from front in order to bring glory to the Institution. **I expect the University to reciprocate in the same manner by relieving me at the earliest, if possible from immediate effect, so that I can shape and plan my academic career.** I believe that plain insistence of compliance of the notice period will serve no purpose because it will create a situation which will compel me to leave the institution in midst of academic semester. Moreover, if the University relieves me at the earliest it would be easier for it to arrange a replacement (rather than doing the same during the semester) as the preparations for the forthcoming semester are already underway.




