2. **Extension of Tenure/Nomination of a person to the Search Committee.**

Notes:

The Executive Council has option of extension of tenure of or nomination of a person as per provisions given below:

As per Section 5(xxxix) and Section 9(2) of the Hidayatullah National University of Law Chhattisgarh Adhiniyam, 2003; the Executive Council of the University in its meeting dated 18.12.2005 has approved the HNLU Staff Regulations which interalia contain the mode of appointment of the Vice-Chancellor of the University.

Quote

"8.3 Mode of Appointment

(1) The Vice-Chancellor

(a) The Vice-Chancellor shall be appointed by the Chancellor as per the provisions of Hidayatullah National University of Law Act, 2003.

(b) On the basis of satisfactory services, after the expiry of normal tenure of 5 years, the Executive Council may request the Chancellor to consider extension of the tenure. Such extension of tenure of the Vice-Chancellor can be extended upto the age limit of 65 years."

OR

Provisions of Statute 19(2)(i) of the Hidayatullah National University of Law Chhattisgarh Act 2003 are as under:

"19(2)(i)

The Search Committee, referred to in sub-section (1), shall consist of the following:-

(i) A person nominated by the Executive Council who should not be connected with the University or any other college affiliated to the University or any institution thereof;"

The matter is placed before the Executive Council for decision either for nomination or recommendation (as aforementioned).

3. **Perusal and approval of recommendations of the Selection Committees for appointment to teaching and non-teaching posts.**

Notes:

The University advertised various vacant teaching and non-teaching posts vide notification No.3 dated 09.10.2009 and No.4 dated 22.12.2009. Due to receipt of insufficient number of applications against these advertisements, vide two corrigendums, the last dates of application was extended upto 01.05.2010. Selection Committee meetings for these posts were held on 04.05.2010 and 05.05.2010. Recommendations of the Selection Committees for appointment to teaching and non-teaching posts are being placed before the Executive Council for perusal and approval.
