2. The period of internship shall be for six months, which may be extended up to maximum period of one year on the basis of report of the Committee evaluating their efficiency and performance of work.
3. If the work or the activity of any Law intern is found to be unsatisfactory or against any rules of the department his internship shall be terminated forthwith by the State Government.
4. During the period of internship consolidated Stipend Rs. 50,000/- (Fifty Thousand Rupees) per month shall be payable.
5. The student shall not be eligible for any other facility during aforementioned period.
6. Students shall have to perform their work under the direction and control of Principal Secretary (Law).
7. The decision of the Law Department in the Government shall be final and binding on the matters relating to internship.
