We are pleased to inform you that Co-operative School of Law and MKMS Education, in collaboration with Mahatma Gandhi University and Kerala State Mediation and Conciliation Centre of the High Court of Kerala, are jointly promoting a series of online events to promote mediation titled Settle 2021.

- Settle 2021 specifically aims (a) to generate wider interest in, and acceptance of, mediation as a dispute resolution tool in Kerala, and (b) to equip professionals and emerging professionals with knowledge and skills to take an active role in mediation.
- Settle 2021 will **formally be inaugurated on 5 March 2021 at 5.30 pm IST on Zoom by Dr KT Jaleel, the Minister for Higher Education, Government of Kerala.** Prof Dr Sabu Thomas, the Vice-Chancellor of the Mahatma Gandhi University, will preside over the inaugural session. - With **60+ sessions spread over 35+ days, 40+ speakers from across the world and 100+ hours of interactions**, Settle 2021 is easily the biggest online gathering yet in the Kerala legal history. There will be four international panel discussions on recent developments in mediation, a mock national-level mediation contest for law schools, 25 awareness sessions to selected organizations across Kerala including law schools, trade bodies and professional associations, two workshops - one for the law students and one for young lawyers, and a faculty capacity building programme for the law teachers.
- **All events of Settle 2021 will be conducted via Zoom video conferencing application.** All events will be accessible free of charge subject to availability of seats, except workshops for which a small fee will apply.
