The rules, regulations framed for utilizing the State Govt. Grant in Aid fund for participation in Conferences, Seminars and Workshops for presenting paper was circulated on 13.03.2019.

This rules and regulations have been updated for participation in Moot Court and also for other academic events are presented for approval herewith to the Finance Committee.

Decision:

The Finance Committee recommends approval to use the grantin-aid which was hitherto given for participation in Moot Court Competitions, also for participation of students in National and International Conferences, Seminars, Workshops and other academic events

The Finance Committee also recommends approval to revised rules for participation of students in National and International Moot Court Competitions with financial assistance from State Government.

Cumulative Professional Development Allowance (CPDA): Notes:

To augment the research skills and subject knowledge of the faculty, it is proposed to create a Cumulative Professional Development Allowance (CPDA) for each faculty member as in vogue with IITs and IIMs and private law schools.

Particulars of Agenda Item SI.

The Cumulative Professional Development Allowance (CPDA) will be an individual allowance for each faculty (full time/adhoc) annually for a block of 3 years which will cover the expenditure towards registration. travel, stay, hospitality etc. for paper presentations in Conferences, Workshops, Seminars, Colloquiums and Round Tables etc. at National and International Level.

The details of the CPDA and the Regulations in this regard to be framed in accordance with the best practices of IITs and IIMs after approval of the appropriate budget by the Finance Committee and final approval of the Executive Council.

It is proposed that provision of CPDA amounting to Rs.1.00 Lac (Rupees One Lac) per faculty member (both regular as well as ad hoc) per annum amounting to Rs.3.00 Lacs (Rupees Three Lacs) in three years is proposed to be made.

On approval by the Finance Committee, the proposal for CPDA is to be placed before the Executive Council for its final approval.

Decision:

The Finance Committee recommends approval for creation of Cumulative Professional Development Allowance (CPDA), as proposed.

7. Provision for One/Two Credit Courses.

Honorarium payable for per Credit Course to the External/Guest Faculty would be Rs.5,000/- (Rupees Five Thousand) per hour plus travel, stay and food expenditure of the external/guest faculty will be borne by the University during the conduct of the credit course. The external/guest faculty will have to put in at least two hours per day towards the credit course. A credit course will be started if a minimum of 10 students opt for it and the maximum to be prescribed by the Faculty.


