Notification for Admission to the B.A.LL.B.(Hons.) / LL.M. Program under Supernumerary Quota for the Wards of Kashmiri Migrants (Academic Session 2021-22)

Date: 30th July 2021

As per the Circular/Directives issued by the University Grants Commission (UGC) as well as Ministry of Human Resources Development (MHRD), Government of India, Hidayatullah National Law University (HNLU), Nava Raipur, Atal Nagar, Raipur has **five seats** reserved for the Wards of Kashmiri Migrants for admission to the B.A.LL.B. (Hons.) Program. Similarly, **two seats** are reserved for the Wards of Kashmiri Migrants for admission to the LL.M. program offered by the University. Interested eligible candidates belonging to the abovementioned category (i.e. those who have applied for and appeared in the CLAT-2021 under the Kashmiri Migrants Category), may directly apply to the University in the prescribed Application Form with the copies of the following certificates/documents:

- Copy of the Birth Certificates
- Copy of current Residential Certificate
- Copy of Certificate issued by Competent Authority in support of claim for being the Ward of Kashmiri Migrants
- Copy of the Statement of Marks obtained in the Qualifying Examination, i.e. Senior Secondary School/Intermediate (10+2) or its equivalent along with conversion certificate in case of grade system.
- Copy of Statement of Marks obtained in the Qualifying Examination, i.e. B.A.LL.B., LL.B./B.L. or any other equivalent degree from a recognized University.

The scanned copy of the filled-in Application Form along with the digital (scanned) copies of required documents converted/saved into a single PDF file in the order as given above must be submitted through email to: admission@hnl.ac.in with a copy marked to: registrar@hnl.ac.in **latest by 05:00 p.m. of 10th August 2021** with the application fee of **Rs. 1,000/-** payable through NEFT only as per the Bank Account details given below.

The NEFT can be made either through one's personal net banking account or by visiting the banks located nearby. However, the candidates are requested to make the NEFT payment by visiting the banks nearby and obtain the UTR No. from the Bank and furnish the remittance details in the form of (a) Amount of fees paid, (b) UTR No. for the NEFT, (c) Name of Bank & Branch (d) Date of Payment, (e) A/C No. of the Remitter, and (f) Name of the A/C Holder/Remitter in the space specified in the Application Form
