### Certificates/Documents Required to be Submitted for Completing Admission

In order to complete the admission formalities, the candidates selected above are required to send the scanned copy of following certificates/documents saved into a single PDF file in the same serial order as mentioned below at [admission@hnl.ac.in](mailto:admission@hnl.ac.in) on or before 5:00 p.m. of 20<sup>th</sup> August 2021.

1. Digital copy of recent passport size colour photograph
2. Copy of the Birth Certificate in proof of age
3. CLAT-2021 Admit Card
4. Copy of the Statement of Marks obtained in the Qualifying Examination, i.e. Senior Secondary School/Intermediate (10+2) or its equivalent (With Conversion Certificate issued by the Competent Authority stating the percentage of marks equivalent of the grades obtained, in case the Statement of Marks is issued in terms of Grades)
5. Certificate recognizing the qualifying examination passed (candidates who have passed the qualifying examination from a country other than India are required to submit a certificate from the Indian Embassy/Indian Consulate or the Association of Indian Universities (AIU), New Delhi, stating that the examination passed by the candidate is equivalent to the qualifying examination prescribed by various education boards in India)

6. Copy of Money Transfer Certificate/Receipt to HNLU Bank A/C along with Conversion Certificate
7. Proof of Nationality (Copy of valid Passport of NRI Candidate/Parent)
8. NRI Certificate issued by the Indian embassy/consulate in the concerned country
9. Copy of the Passport of Parent working abroad/Copy of the work Permit/License to work of parent/copy of resident Permit of Parent/Letter from employer of the parent
10. English translation of all documents & transcripts duly attested
11. Undertaking of parent for financial support to the candidate including payment of fees as prescribed for NRI category by HNLU
12. Transfer Certificate, Character Certificate and Migration Certificate from the Institution last attended
13. Declaration by the Candidate (To be printed on non-judicial stamp paper worth Rs. 50/-) (Annexure -1).
14. Declaration by the Parent/Guardian of the Candidate (To be printed on non-judicial stamp paper worth Rs. 50/-) (Annexure-2).

The certificates/documents mentioned in Sl. No. 7 to 9 are essential in nature and the admission under NRI category is being offered on that basis. Hence, it is mandatory for candidates to submit these certificates/documents on or before the time and date specified above failing which the candidates shall forfeit the offer of admission made to them. However, the candidates lacking in other documents may be allowed to complete the admission formalities by submitting an undertaking to that effect.

**Important Notes:**

1. Provisional admission to the selected candidates would be offered only after verifying the certificates/documents and satisfying all eligibility conditions.
2. The candidates who fail to complete the admission formalities as mentioned above on the date of admission shall forfeit the offer of admission made to them.
3. In case any discrepancy is found in the documents submitted, the university reserves the right to cancel the admission and take legal action against the candidate.
