IMPORTANT NOTES FOR WAITLISTED CANDIDATES

In case the waitlisted candidates do not express their willingness in writing to the Admission Committee that they are interested in taking admission and will be depositing the admission fees and certificates/documents as mentioned above, in the event of any seat falling vacant, they will forfeit their right to be considered for admission and the persons next in the merit list, who would have expressed their interest in writing, will be offered the provisional admission.
