the Fee Committee on such appeal will be intimated by 22nd December 2022 and shall be final.

4. The late fee @100 per day after 26th December 2022 is to be applicable till 2nd of January 2023.
5. The students who are making payment through Direct transfer (due to Educational loan) are required to share the payment details within 24 hours for verification by Accounts section failing which the fees shall remain unpaid on their account due to non-verification and they shall be solely responsible for the necessary action by the University Authorities.
6. If the student fails to pay the semester fee beyond the timeline of 2nd January with late fee (unless exempted by the fee committee), the name of the student will be removed from the rolls of the attendance of the semester starting 4th January 2023.
7. Those who are applying and found eligible under the Vice Chancellor Means/Merit Scholarship will be reimbursed after the consideration of the committee dealing with the scholarship.
