1. If applicable Bidder has to submit Earnest Money Deposit Rs. 20,000.00 through DD to “Registrar, Hidayatullah National Law, University”, Account No: 049104000329378, IFS Code: IBKL0001188, BRANCH NAME: HNLU Campus, Uparwara, Raipur, Bank Name: IDBI Bank Ltd. should be included in the part of tender document towards Earnest Money.
2. The Earnest Money deposit by a Demand Draft in favor of Registrar, Hidayatullah National Law University, Raipur shall be accepted by the Institute. A tender which is not accompanied by EMD will not be considered. The EMD will be returned to the bidder if their tender is not accepted by the Institute but without Interest. The EMD paid by the successful bidder shall beheld/encashed by the HNLU as security for execution and fulfillment of the contract. No interest shall be paid on this deposit.
3. The **Envelope-1 & 2** with subject “**EMD, Technical & Prequalification bid for “Supply, Installation, Configuration and Commissioning of CORE Networking Manageable Layer 3 Switch for HNLU Raipur”**” shall be opened by REGISTRAR or his authorized representative in his office on the same day at 4:00 PM. In case, holiday is declared by the Government on the day of opening the bids, the bids will be opened on the next working day at the same time.
4. **Financial bid** of only qualified bidders will be opened. The date of opening of financial bid shall be informed by the institute to the qualified bidders.
5. Tenders shall remain valid for acceptance by the Institute for a period of three months from the date of opening of the tender which period may be extended by mutual agreement and the bidder shall not cancel or withdraw the bid during this period.
6. The bidder must use only the formats issued by the Institute to fill in the rates. Any addition/alteration in the text of the Tender form made by the bidder shall not be valid and shall be treated as null and void.
7. The Tender form must be filled in English. If any of the documents is missing or unsigned, the tender may be considered invalid by the Institute in its discretion.
8. Rates should be quoted both in figures and in words in columns specified. Overwriting of figures is not permitted. Failure to comply with either of these conditions will render the tender void at the Institute's option. No advice whatsoever especially on any change in rate specifications after the opening of the tender will be entertained.
9. TERMS AND CONDITIONS

Upon the declaration of an intending vendor/bidder to be the Successful Bidder by the Institute, they shall be subject to the following terms and conditions that shall form part of the Formal Contract to be executed with the Institute.

1. The successful bidder shall not assign the sub-contract. In case of breach of these conditions, the HNLU may serve a notice in writing on the Contractor rescinding the contract.

2. The successful bidder shall carry out all the work strictly in accordance with scope of work, technical specifications and as per detailed instructions of the Institute.

3. The successful bidder must cooperate with the other contractor appointed by the Institute so that the work shall proceed smoothly to the satisfaction of the Institute.

4. In all matters of dispute arising on the work, the matter shall be referred to **The Registrar, Hidayatullah National Law University, Raipur** for a mutual decision.

5. **Arbitration Clause:** In the event that the Successful Bidder is not satisfied by the decision of the **The Registrar, Hidayatullah National Law University, Raipur**, the dispute shall be settled by arbitration in accordance with the provisions of arbitration and conciliation act, 1996 or any enactment thereof. The Arbitral Tribunal shall consist of one arbitrator, to be appointed by the Institute. The place of arbitration shall be Raipur and any award whether interim or final, shall be made, and shall be deemed for all purposes between the parties to be made in Raipur. The arbitration proceedings shall be conducted in the English language and any award or awards shall be rendered in the English language. The procedural law of the arbitration shall be the Indian law. The award of the arbitral tribunal shall be final, conclusive and binding upon the Successful Bidder and the Institute.

i. Payment will be released only after successful installation and commissioning of the equipment ordered. No advance payment will be made.

ii. Income tax and all other applicable taxes shall be deducted at source as per prevailing Govt. Rules in this regard.

Delivery & Installation: The items ordered must be delivered, installed, Configured and commissioned within a period of 20 days from the date of placing the purchase order. The installation will be considered complete and warranty period will commence only when all the components of hardware, software, etc. are installed, commissioned and working satisfactorily.

7. Warranty and Support:

Switches should have a **5 years** comprehensive onsite warranty/support 8x5xNBD from the date of successful installation.

8. Penalty:

If the selected firm fails to deliver the service, penalty to such effect would be charged. HNLU reserves rights to forfeit the security deposit if any.

Eligibility for Bidders

The Agencies that fulfil the following requirements shall be eligible to apply:

- a) Copy of Registration of Firm Certificate of Incorporation of company or Partnership deed.
- b) Copy of Registration of Goods & Service Tax and PAN
- c) The bidder should have an average annual turnover of INR 30 Lakh in the last 3 financial years. Submit copies of audited Balance Sheet and Profit & Loss account /CA Certificate for the last three years.
- d) OEM certificate/ authorization letter related to the tender.
- e) Either the Registered Office or one of the Branch Offices of the bidder should be located in Raipur, Raipur suburban, or Chhattisgarh.
- f) The OEM / their authorized partners should have at least **five years of experiences** in similar volume of works of supply, installation and maintenance of networking switches for the Government (State/ Central/Autonomous) organization/institutes/universities, as on tender submission deadline.
 - i) at least 01 similar work of value not less than Rs. 8 Lakh OR
 - ii) at least 02 similar works of value not less than Rs. 6 Lakh OR
 - iii) at least 03 similar works of value not less than 4 lakh. References order copy proof of completion certificate for the project must be provided.
- g) The bidder should not be black listed by any Govt. organization /PSU during last 3 years. A declaration certificate to this effect is to be submitted as per the format given in Annexure-1.

SECTION-‘E’

Technical BID

HNLU is spread across 65 Acres of land and the institute has a small server room. The entire campus is inter-connected with Local Area Network, Wi-Fi, connecting desktops and laptops and mobile devices. The IT Section provides all the services 24 x 7 to 1200 users.

HNLU invites quotations from the reputed vendors for supply, installation, Commissioning and support of Institute standard networking switch.

SPECIFICATION & Scope

The scope of the work involves following activities.

1. The Vendor shall supply, install, configure, test and commission **CORE Networking switch Manageable Layer 3 Switch and must be compatible with existing network.**

a. **The work shall include all components including all the parts and licenses.** Materials, if required for the installation of the above switches have to be supplied by vendor at free of cost.

b. The work involves removing the existing core switch and installing and configuration, testing and commissioning switch and creating all the existing VLANs, routing, snooping and if required re-configuring Access switch connected to the Core for smooth function of LAN with new core L3 switch. Adding the switches to NMS (IPswitch) used by the Institute.

c. **The core switches will be connected to Sophos Firewall with cat 6A or cat 7 cables . All access switches around 15 nos (24 port 1G/10G with four SFP uplink) from different buildings are currently connected to the core Layer 3 D-Link switch with 1G/10G SFP modules and fiber patch cable. The bidder should migrate these connections to the new core layer 3 manageable switch. Bidders should check that the existing 1G/10G SFP module (brand Brocade ,E1MG-LX-OM) should be compatible with core layer 3 manageable switch otherwise the 10G modules to be included in the cost (12 nos 10G SFP and 4 no’s 10G Ethernet modules for core layer 3 switch) .**

d. **Contractor should visit the site before submission of the tender and ascertain the suitability for installation, testing, configuration and commissioning (internet check with all distribution switch installed in various place/buildings) of the proposed work to be offered by them. Before quoting the rates, the bidder should inspect the site and get acquainted with work.**

e. Annually preventive maintenance of equipment to ensure smooth operation of the equipment installed.

f. The Network engineer should be well-trained customer support engineer in all respects i.e. well mannered, technically sound and having vast knowledge in the field. The bidder should have at least one qualified(CCNP or equivalent) Network engineer to configure / attend any service call immediately or within 4 hours from the time of the reporting the problem. Name and contact details along with the call matrix to be provided.

2. Warranty/Support & Maintenance.

The vendor shall provide support **8x5xNBD** to keep the systems in good working order for five years. Complete Technical support including upgradation of software for the equipment installed at HNLU Campus by themselves or through OEM to resolve issues at HNLU.
