EXPRESSION OF INTEREST (EOI)

EOI for Empanelment of Technical Consultants for Architectural, Planning & Designing along with Engineering Services for various projects in HNLU .

1. Introduction

Established in 2003, Hidayatullah National Law University has completed the journey of more than one and half a decade. In such a short span of time, HNLU has carved out a niche in the realm of legal education across India and the legacy is soaring towards newer heights day by day. Named after the great legal luminary Justice Mohammed Hidayatullah, the University was established by the Government of Chhattisgarh under the Hidayatullah National University of Law, Chhattisgarh, Act (Act No.10 of 2003).

HNLU is the sixth in the series of National Law Schools across India. HNLU has been included in the list of the Universities maintained by the University Grants Commission under Section 2(f) of the UGC Act, 1956 and has been declared fit to receive Central assistance in terms of the rules framed under Section 12 (B) of the UGC Act, 1956. The university is recognized by the Bar Council of India under section 7 of the Advocates Act 1961.

As a fully residential university, HNLU has separate Halls of Residence for boys and girls. The first year students are given an accommodation of two in one room for both boys and girls in the hostels. From second year to fifth year students are given accommodation of single rooms in the hostels having a capacity of 800 rooms furnished with cots, tables and storage space. The University has a separate PG Hostel for Girls having a capacity to accommodate 30 students. Further, there are two more hostels constructed for both boys and girls. There is a recreational TV room as well.

The hostels on campus have a boys and girls dining halls with a seating capacity of 150 each. The single room hostels have a balcony to individual room and a courtyard. All the floors have water coolers and a centralized RO plant is under commission. The solar heater equipped with alternate electrical heater supplies water to the shower rooms.

Sports

Both boys and girls have a state of the art Gymnasium in the central hostels with indoor badminton courts and table tennis facility. Outdoor sports facilities inside the campus include a Football ground with a proposed synthetic running track around it, a Cricket ground, Lawn tennis court, two Basketball courts and one Volley ball court respectively.

Transport

The University has three buses of 40 seater capacity which shuttles in the evening from campus to city centre at periodic intervals. The transport fees of the university entitles the

students for a ride to shop and meet their food and entertainment needs in the city. Apart from the University transport the city transport corporation buses ply every 20 minutes from the main road in front of the campus gate to the major points of the capital region and Raipur city.

The airport viz Swami Vivekananda Airport is just 15 minute drive from the campus and the Raipur railway station is 35 km. from the campus.

Medical and Health Facilities

The BALCO hospital is a new healthcare amenity in the vicinity of the university. The Ramakrishna hospital which is around 15 minutes from the University is a multi-specialty hospital catering to the needs of the HNLU fraternity. The city of Raipur has AIIMS which is a high-specialty medical complex.

Food Court

Apart from the dining hall, the University has multi-need complex where eight shops are operated on contract basis selling snacks, ice creams, beverages and minor needs. The campus has also a coffee day outlet in the shopping complex. The hostels do have a small canteen outlet catering till 2 A.M.

Cultural Space

The University is a diverse space for students across the country living, studying and learning. There are students from every state and union territory imparting the unity in diversity spirit. The student initiative of **Colossus** is a three day festival of culture and sports, The festival attracts students across the country. The festival has exposition of students creative talents of western, classical and folk genre in music and dance.

HNLU intends to develop its campus considering the present need of infrastructure and facilities keeping in mind future expansion of the university.

2. Invitation for Expression of Interest

Expression of Interest (EOI) is invited for the empanelment of consultancy services from qualified, experienced, competent, financially sound and nationally acclaimed Technical Consultants including overseas firms for the various upcoming Layouts, buildings / structures and campuses along with necessary infrastructure facilities at HNLU.

The work also includes the detailed design including preparation of layouts, architecture, structures, infrastructure such as road, water supply, sewerage network, electrical and telecommunication, utilities, landscape, signage etc. and the preparation of cost estimates, bills of quantities, and periodic site supervision of project till completion.

All applications are to be submitted in the specified format with additional information to be given as required. Such an organization is hereinafter referred to as "Applicant". Once the applications

are received, they will be screened to prepare a short list of applicants who may be invited to participate in the further stages of selection.

3. Broad Scope of Work

HNLU intends to empanel list of technical consultants for various types and scale of works to develop master plans and their detailing for the upcoming buildings / structures and campuses along with necessary infrastructure facilities. There are two types of typical assignments, which include:

- a. **Comprehensive Architectural and Interior Design Services:** Preparation of Comprehensive Architectural Design (Site/ Campus plan, building/ structure design and drawings). Preparation Interior Design drawings (Wall elevations, views, Furniture Layout drawings, colour theme, flooring details and other interior related works).
- b. **Infrastructure Design Services-** Infrastructure including Roads/ Drains/ Sewerage/Rain Water Harvesting / Landscaping or Landscape development/ gardens/ Pond beautification and other Development works.

In both cases, the scope of work includes GAD design, structural design, service design and preparation of working drawings, preparation of cost estimates, bills of quantities, obtaining statutory approvals and periodic site supervision of project till completion.

Detailed scope of work shall be provided in the subsequent RFP document depending on type and scale of project.

4. Category and Services for Empanelment

- a. The inclusion of the Technical consultant for specified category and the type of services would be as per eligibility criteria as set out in this document.
- b. The applicant may apply for both the following cases but in one of the categories in each case as stated below.

i.) Case 1: Comprehensive Architectural and Interior Design Services:

5. Selection Procedure for Empanelment

The procedure for listing of consultants shall be as under:

- a. Invitation of Expression of Interest (EOI): HNLU invites the application from eligible consultants to submit their expression of interest to participate in the empanelment procedure.
- b. Submission of EOI: The participants will submit the EOI to HNLU along with the details as required in the prescribed manner. The participants shall submit along with the Technical Proposal the following supporting documents in support of its eligibility.

- c. Scrutiny by HNLU: HNLU will scrutinize all the submissions received on the basis of eligibility criteria. The certificates issued by Central/ State Govt., Central/ State Public sector, Municipal Corporation and Development Authorities will only be taken into consideration.
- d. Empanelment: The eligible participants will be selected for the empanelment on the basis of their competence and previous works.

6. Period of Empanelment

The empanelment will be for a period of One year and will require renewal after one year; if not renewed, it will expire automatically. The renewal application shall be submitted 3 months before date of expiry of empanelment to the Registrar, HNLU. The renewal fees will be decided from time to time

7. Termination of Empanelment

If in the view of the REGISTRAR the performance of a consultant is not satisfactory, or if in her/ his

view the consultant has failed to safeguard the interest of HNLU, Competent Authority may at her/his sole discretion, terminate the engagement of the consultant for the particular project as well as proceed for termination/ suspension/ deration of empanelment with HNLU by giving written notice by not less than 30 [thirty] days to the consultants. The decision Competent Authority of HNLU in this matter shall be final and binding.

In case of non-participation on behalf of the empaneled consultant in three consecutive projects, the empanelment may be liable for termination at the discretion of HNLU.

8. Procedure for Award of Work

Depending on the nature and requirement of the project, HNLU may adopt any one of the following or any other method as may be required for the project from time to time for selection of appropriate consultant from the empaneled list or open bidding:

- a. Quality based selection with fixed fee (QBS)
Selection of the consultant will be based on all or any of the criteria like design submission, similar experience, team personnel, turn over and/ or presentation, etc. as decided from time to time depending on the project.
- b. Quality and cost based selection (QCBS)
Selection of the consultant will be based on all or any of the criteria like design submission, similar experience, team personnel, turn over and/or presentation etc. along with cost in proportion as decided from time to time depending on the project.
- c. Quality based selection with technical first to match lowest financial bid (T1L1)
Selection of the consultant will be based on all or any of the criteria like design submission, similar experience, team personnel, turnover and/ or presentation etc. The Technical First consultant will be asked to match lowest bid for the award.
- d. Pre-qualification and cost based selection (PQL1)
Prequalified consultants based on all or any of the criteria like design submission, similar experience, team personnel, turn over and/ or presentation, etc. will be listed and final selection will be based on financial bid.
- e. And any other variation of above thereof depending on the nature and requirement of the project.

Further detailing of the selection process and award of work will be defined in the proposal document of the individual projects floated from time to time. HNLU, at its discretion can call for participation through open bidding and/ or along with empaneled consultants for any of the projects, as the case may be.

9. Primary Eligibility Criteria

Interested firms should meet the following prequalification criteria before deciding to submit an EOI response:

- a. The applicant may be an individual, a sole proprietorship firm, or Private Limited Company or Public Limited Company providing services in the relevant category of services.
- b. Joint Venture & consortiums are not allowed.
- c. Minimum educational qualification for services are as listed below:
 - i. **Comprehensive Architectural and Interior Design Services-**
 - &
 - ii. **Infrastructure Design Services-**

The individual or firm of Architects, Planners with multidisciplinary team of engineers, structural designers, landscape designers, PHE/ Electrical experts etc. are eligible to apply for such projects. Individual/ Sole Proprietary firm/All directors of Pvt. Limited company shall be an Architect and have registered from Council of Architecture (with up to date renewal) to be eligible for Empanelment.
- d. The consultant firm should have experience of having successfully completed projects of similar nature and magnitude during last 5 years (as on 31.12.2022) in India and should have an office in India. Proof of completion of projects such as copy of work order, agreement and completion certificate shall be enclosed. Refer to Clause No. 6b.
- e. The consultant shall have adequate and sufficient in-house resources and expertise to deliver this project in a timely manner. Firm shall have a range of relevant in-house expertise including institutional campus planning and design, including the buildings.
- f. The applicant shall be ineligible to submit a proposal, if the organization or any of its constituents has been barred or blacklisted by any Central and/or State Government in India.
- g. Persons who are individually or institutionally in any manner involved with the selection/ screening process of the EOI and employees of HNLU shall be ineligible for applying.
- h. The firms having past experience in execution of green buildings certified by LEED/ TERI shall be given preference in EOI, which shall also be considered as a part of evaluation criteria at RFP Stage.
- i. Preference shall also be given to consultants having executed landmark projects which are globally recognized.

10. Application: Documents and Procedures

- a. The applicant shall bear all costs related to the preparation and submission of EOI. HNLU shall in no case be liable or responsible for these costs regardless of the conduct and outcome of the selection process.
- b. Proposal shall necessarily be accompanied by a Non-Refundable Processing Fee amounting to INR 10,000/- (Rupees Ten thousand only) in the form of a Demand Draft issued by a Scheduled Bank in India, drawn in favour of the REGISTRAR , HNLU , payable at Raipur, Chhattisgarh, India.
- c. The document formally asking for a Request for Proposal (RFP) shall be issued later by HNLU to the short-listed applicants. The contents of the RFP shall take precedence over the brief requirements stated elsewhere in this document.
- d. Offline Applications received will be acknowledged. However, the applicants shall be informed of the status of their application once the short-list is prepared. No separate correspondence shall be entertained in this respect.
- e. Incorrect, incomplete, inadequate information may lead to rejection of the application. Canvassing in any form may lead to summary rejection of application
- f. Applicants shall submit self-attested copies of certificates, appointment letters, work orders, agreements, references etc. as proof of eligibility.
- g. All documents, drawings, maps and other information provided by/to HNLU for the EOI shall continue to remain property of HNLU. All information and documents submitted as part of the EOI application shall become property of HNLU.
- h. HNLU reserves the right to reject any application without assigning any reason. HNLU also will not provide any explanation to the applicants related to the short listing and selection process. The decision of HNLU in this respect shall be final and binding on all applicants.
- i.
