4. The late fee@ Rs.100/- per day for each i.e. Semester Fee & Mess Fee after 25/07/2023 will be applicable till 03/08/2023.
5. The students who are making payment through Direct transfer (due to Educational loan) are required to share the payment details within 24 hours for verification by Accounts section failing which the fees shall remain unpaid on their account due to non-verification and they shall be solely responsible for the necessary action by the University Authorities.
6. If the student fails to pay the semester and mess fee beyond the timeline of 03/08/2023 with late fee (unless exempted by the fee committee), the name of the student will be removed from the rolls of the attendance in addition to late fine of Rs.100/- per day till date of deposit of fee.
7. Those who are applying and found eligible under the Vice Chancellor Means/Merit Scholarship will be reimbursed after the consideration of the committee dealing with the scholarship.
8. NRI Category Students who have Not paid/ Partly Paid their fee are required to contact Accounts Section (feeaccounts@hnlu.ac.in) or 7587017912
9. Students have following options to pay their fee:
 - a. SBI Collect (For Single Transaction of Both Semester & Mess Fee) – 1st Link given in the University Website below the Semester & Mess Fee Notification.
 - b. Pay-Shulk Payment gateway (Students opting separate Transactions for semester and Mess Fee)- 2nd & 3rd Link given in the University Website below the Semester & Mess Fee Notification.
