 1. **Rate / Price:** The Rate should be inclusive of GST which should be indicated separately as applicable. All the rates should be FOR Destination basis (i.e. concerned department).
 2. **Taxes:** Taxes, if any (Kindly mention in above table) should be clearly mentioned in the offer.
 3. **Supply:** Material should be supplied within 15 Days after placement of Purchase Order.
 4. **Sample:** N.A.
 5. **Validity:** Quotation should be valid for a period of 90 Days from the date of Submission of Quotation.
 6. **Consignee:** Purchase In-Charge, Hidayatullah National Law University, Nava Raipur, Atal Nagar, District - Raipur 492002 (C.G.)
 7. **Packaging and forwarding charges, Freight, Loading / Unloading:** Inclusive.
 8. **Quality & Workmanship:** All the material shall be of the best Class, Quality and workmanship shall be of the best grade.

 11. **Penalty:** In case Of Delay in Non-Completion of supply, Penalty / LD @ 1/2% (Half Percent) Of Price for Each week Or Part There of subject to maximum of 10% (Ten Percent) will be imposed.

 13. Documents relating to the registration of the firm i.e., GST and relevant documents should be submitted along with quotation.
