## Important Information Pertaining to Admission under Reserved Category Seats at HNLU, Raipur

Date: 26th December 2023

- 1. The candidates seeking admission at HNLU under any of the reserved categories must upload the relevant certificates at the time of admission failing which the admission offered will stand cancelled.
- 2. To avail the reservation facility under Chhattisgarh Domicile SC/ST/OBC or Dependents of Freedom Fighter (DFF) Category, the candidates must upload/submit the CG Domicile Certificate and relevant Caste Certificates issued by the competent authority from the State of Chhattisgarh. For example, a SC/ST/OBC or DFF candidate from Madhya Pradesh/Odisha or any other state, who has been staying in Chhattisgarh for some years and has legally been issued a Domicile Certificate by the competent authority of the State of Chhattisgarh, cannot claim reservation under Chhattisgarh Domicile SC/ST/OBC or DFF category by producing a Caste Certificate or DFF Certificate issued by the Government of MP/Odisha or any other State Government. However, he/she can avail the reservation facility under All India SC/ST/OBC seats at HNLU provided he/she has the required merit for the same, i.e. All India Rank. He/she too can be considered for Chhattisgarh Domicile Unreserved Category seats based on the Domicile Certificate issued by the competent authority from the State of Chhattisgarh provided he/she has the merit for the same. To avail the reservation under Chhattisgarh Domicile SC/ST/OBC or DFF Certificate issued by the competent authority from the State of Chhattisgarh itself.
- 3. However, the All India reserved category candidates such as SC/ST or OBC are required to produce caste certificates issued by competent authorities from the state of their domicile.
- 4. To claim reservation under SAP/PWD category seats, as provided under CLAT 2024, the candidate should have the required disability of 40% or above.
- 5. The Caste Certificates are to be issued by Competent Authorities not less than the rank of a Tehsildar/Naib Tehsildar.
- 6. To avail the reservation under OBC category, an OBC candidate (All India or CG Domicile Category) must produce the OBC Non-Creamy Layer Certificate clearly stating that the candidate doesn't belong to the 'Creamy Layer' category. Further, the OBC Certificate must not be more than one year old to be counted from the date of submission of the certificate. While the All-India Category OBC-NCL Category Candidates for admission to the B. A. LL. B. (Hons.) as well as LL. M. Program are required to submit the OBC-NCL Certificate as per the Central Government Format, the CG Domicile OBC-NCL Category Candidates for admission to the B. A. LL. B. (Hons.) Program may submit the OBC-NCL Certificate in Central Government Format or C. G. State Government Format.
- 7. For availing reservation under the Dependents of Freedom Fighters (DFF)) category seats at HNLU, the candidate must be a domicile of Chhattisgarh and must produce the DFF and Domicile Certificate issued by the competent authorities from the State of Chhattisgarh. No DFF candidate from outside the State of Chhattisgarh can take admission under DFF category seats offered by HNLU.
