# Notification Inviting Application for Admission to the B. A. LL. B. (Hons.) Program under Non-Resident Indian (NRI) Category Seats

(Academic Session 2024-25)

Date: 01.01.2024

As specified in the CLAT-2024 Brochure, Hidayatullah National Law University seeks to invite applications from eligible NRI candidates for filling up the **08 seats** under the Non-Resident Indian (NRI) Category. In order to be considered for admission under NRI category, the applicant must be:

- A Non-Resident Indian or either of his/her parents must be a Non-Resident Indian; and
- He/she must have applied for and appeared in CLAT-2024 under the NRI Category.

Interested eligible candidates belonging to the NRI category may directly apply to the University in the prescribed Application Form along with the copies of the certificates/documents specified below:

## **Application Procedure:**

The interested eligible candidates are required to directly apply to the University following the two steps mentioned below:

- 1. First, make payment of the Non-refundable Application Fee of Rs. 1000/- by clicking on the link: <a href="https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=5675243">https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=5675243</a> and save a soft (digital) copy of the Payment Acknowledgement Receipt on the desktop; and then
- 2. Second, fill the Google Form clicking on the link: <a href="https://forms.gle/D4VzGZ2Z9CWSJhvp8">https://forms.gle/D4VzGZ2Z9CWSJhvp8</a> and upload the copies of the following certificates/documents:
  - a) Copy of Birth Certificate
  - b) Proof of Nationality (i.e., Copy of valid Passport of NRI Candidate or of the Parents)
  - c) NRI Certificate issued by the Indian Embassy in the concerned country
  - d) Copy of the Passport of Parent working Abroad/Copy of the work Permit/License to work of Parent/Copy of Resident Permit of Parent/Letter from Employer of the Parent.
  - e) Acknowledgement Receipt of Non-refundable Application Fee of Rs. 1000/- payable online through the link: https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=5675243

Please click on the fee payment link first for paying Application Fee of Rs. 1000/- and save the digital copy of the Payment Acknowledgement Receipt on the Desktop and then click on the Google Form Link to submit your application after uploading the Fee Payment Receipt and other documents.

### **Certificates/Documents required to be submitted at the time of Admission:**

- 1. Proof of Nationality (Copy of valid Passport of NRI Candidate or of the Parents).
- 2. NRI Certificate issued by the Indian embassy/consulate office in the concerned country.
- 3. Copy of the Passport of Parent working abroad/Copy of the work Permit/License to work of Parent/Copy of Resident Permit of Parent/Letter from Employer of the Parent.
- 4. English Translation of all documents & transcripts duly attested.
- 5. Undertaking of Parent for financial support to the candidate including payment of fee as prescribed for NRIcategory by HNLU.
- 6. Copy of the Statement of Marks obtained in the Qualifying Examination, i.e., Senior Secondary School/Intermediate (10+2) or its equivalent (With Conversion Certificate issued by the Competent Authority stating the percentage of marks equivalent of the grades obtained, in case the Statement of Marks is issued in terms of Grades).
- 7. Certificate recognizing the qualifying examination passed [Candidates who have passed the qualifying examination from a country other than India are required to submit a certificate from the Indian Embassy/Indian Consulate or the Association of Indian Universities (AIU), New Delhi, stating that the examination passed by the candidate is equivalent to the qualifying examination prescribed by various education boards in India].
