Payment Methods

- For Students Other Than NRI Category:** Payments can be made through the following link:

- For Students Enrolled Under NRI Category:** The semester fee should be deposited directly into the university bank account. Bank account details will be shared by the Accounts Section via email upon inquiry from student.
- After payment, students must share the payment details within **24 hours** at feeaccounts@hnlu.ac.in for verification. Unverified payments will be held in suspense, and the student's name will be marked in the unpaid list.

Important Notes

- Mess charges are not included in the above fee structure. A separate notification regarding mess fees will be issued in due course.
- Students must strictly adhere to the specified payment modes to avoid data mismatches and subsequent inclusion in the unpaid list.



3. Ensure all payment details, such as student ID and name, are entered correctly and match university records.

5. Students availing scholarships or facing financial difficulties in meeting the deadline must write to **feescommittee@hnlu.ac.in** by **20.12.2024**. Decisions will be communicated by **24.12.2024** and will be final.
6. A late fee of **₹100 per day** will be charged separately for semester and mess fees, subject to a maximum of **₹2,000 each**.
7. Non-payment beyond **20 days** after the deadline, without specific exemption, will result in removal from attendance rolls and a **penalty of ₹5,000** for reinstatement in addition to the dues.
8. Days marked absent due to non-payment will not be reversed and may lead to debarment from examinations.

All students are advised to adhere to the above guidelines to ensure a smooth payment process and avoid penalties.
