Engagement of Law Interns for Legal Assistance to Nava Raipur Atal Nagar Development Authority (NRDA)

Hidayatullah National Law University (HNLU), Raipur invites Expression of Interest from eligible law graduates for engagement as Law Interns with the Nava Raipur Atal Nagar Development Authority (NRDA). The interns will assist the concerned officers in handling various legal matters pending before different judicial and quasi-judicial forums.

Position

Law Intern (02 Positions)

Nature of Work

The selected interns will provide legal assistance to the concerned officers of NRDA in relation to:

1. **Land Disputes** pending before:
 - Hon'ble Supreme Court of India and Hon'ble High Court
 - Civil Courts and Revenue Courts
2. **Regulatory Proceedings**
 - Matters before the Real Estate Regulatory Authority (RERA)
3. **Civil and Commercial Matters**
 - Contractual disputes and Arbitration proceedings
4. **Service Matters**
 - Legal issues relating to employment/service disputes
5. **Other Legal Assignments**
 - Legal research and preparation of case briefs
 - Assistance in drafting legal notes, replies, and documentation, and
 - Case tracking and coordination with legal counsel

Eligibility

Applicants must:

- Hold a B.A. LL.B. (Hons.) degree from a university recognised by the Bar Council of India and must have graduated in the academic year 2024–2025.
- Demonstrate a keen interest in litigation, land law, administrative law, and public law.
- Possess strong legal research, analytical, and drafting skills.

Stipend

Selected interns will receive a monthly stipend of ₹50,000/- in accordance with the policy of the Law and Legislative Affairs Department, Government of Chhattisgarh.

Location

Nava Raipur Atal Nagar Development Authority (NRDA), Raipur, Chhattisgarh

Duration

The duration of the internship will be as determined by NRDA, subject to institutional approvals.

- Final selection will be made by the NRDA.
