- The candidates selected for provisional admission are required to pay an amount of **USD 6000.00 plus INR 1,15,000.00** and submit the relevant certificates/documents specified below latest by **05:00 p.m. of 22<sup>nd</sup> May 2026**. For fee details, please click on the 'Fee Structure' given on the Admission Page of HNLU Website ([www.hnlu.ac.in](http://www.hnlu.ac.in)).
- The candidates can make payment through any bank as per the account details given below and submit the digital/scanned copy of Fee Payment Receipt containing the amount of money transferred to HNLU Bank A/C and the Unique Transaction Reference (UTR) Number. While the candidates/parents staying abroad can make payment in US Dollars, the candidates staying in India can make payment in INR. However, in such cases, the candidates are required to submit a Conversion Certificate regarding the Current Exchange Rate of US Dollar to be issued by the Bank doing the money transaction.
- In case any selected candidate fails to pay the fees and/or submit the required certificates/documents by the specified date and time given above, such selected candidates shall forfeit the offer of admission made to them. The Admission Committee will not entertain any request/communication in this regard.
- The offer of admission made is provisional and it does not confer any right in favour of the candidate. The university shall not be responsible for any expenditure made by the candidate in this regard.

## **Certificates/Documents Required to be Submitted for Completing the Admission Formalities**

In order to complete the admission formalities, the candidates selected above are required to send the scanned copy of following certificates/documents saved into **a single pdf file** in the same order as mentioned below to: [admission2026@hnlu.ac.in](mailto:admission2026@hnlu.ac.in) latest by 05:00 p.m. of 22<sup>nd</sup> May 2026.

1. Digital copy of recent passport size colour photograph
2. Copy of the Birth Certificate in support of proof of age
3. CLAT-2026 Admit Card (Signed by the Candidate and the Invigilator)
4. Class 10 Marks Statement-cum-Certificate
5. Class 12 Statement of Marks-cum-Certificate, i. e. Senior Secondary School/Intermediate (10+2) or its equivalent (Please submit a Conversion Certificate issued by the Competent Authority stating the %age of marks equivalent of the grades obtained, in case the Statement of Marks issued is in Grades).
6. Transfer Certificate, Migration Certificate and Conduct Certificate from the Institution last attended (*In case of non-availability of these certificates (mentioned in Sl. No. 5 & 6), an undertaking can be submitted stating that these certificates would be submitted by 5<sup>th</sup> July 2026 failing which the provisional admission given to the candidate may be cancelled*).
7. Certificate recognizing the qualifying examination passed (Candidates who have passed the qualifying examination, i. e. 12<sup>th</sup> Class, from a country other than India are required to submit a certificate from the Indian Embassy/Indian Consulate or the Association of Indian Universities (AIU), New Delhi, stating that the examination passed by the candidate is equivalent to the qualifying examination prescribed by various education boards in India).
8. Proof of Nationality (Copy of valid Passport of NRI Candidate/Parent).
9. NRI Certificate (of parent/candidate) issued by the Indian Embassy/Consulate Office of the country of one's residence. Alternatively, the candidate can submit a valid OCI Card, if he/she happens to be an Overseas Citizen of India.
10. Copy of the Passport of Parent working abroad/Copy of the work Permit/License to work/Copy of Resident Permit of Parent/Letter from employer of the parent.
11. Digital/Scanned Copy of Fee Payment Receipt containing the amount transferred to HNLU Bank A/C, the UTR No. and the Conversion Certificate issued by the Bank through which the amount was transferred.
12. English translation of all documents & transcripts duly attested, in case they have been issued in different languages.

The certificates/documents mentioned in Sl. No. 8 to 10 are essential in nature and admission under NRI category is being offered based on these certificates. Hence, it is mandatory for candidates to submit these certificates/documents on or before the time and date specified above failing which the candidates shall forfeit the offer of admission made to them. However, the candidates lacking in other documents may be allowed to complete the admission formalities by submitting an undertaking to that effect.

### **Important Notes:**

1. Provisional admission to the selected candidates would be given only after verifying the certificates/documents and satisfying all eligibility criteria.
2. In case any discrepancy is found in the documents submitted, the university reserves the right to cancel the admission and take appropriate legal action against the candidate.
