Instructions to SELECTED Candidates for Completing Admission Formalities:

- The candidates selected for provisional admission are required to pay an amount of **Rs. 1,75,000/- (Rs. One Lakh Seventy-Five Thousand Only)** and submit the relevant certificates/documents specified below **latest by 05:00 p.m. of 5th June 2026**. For fee details, please click on the 'Fee Structure' given on the Admission Page of HNLU Website (www.hnlu.ac.in).
- The candidates can make payment through any bank as per the account details given below and submit the digital/scanned copy of Fee Payment Receipt containing the amount of Money Transferred to HNLU Bank A/C and the Unique Transaction Reference (UTR) Number.
- In case any selected candidate fails to pay the fees and/or submit the required certificates/documents by the specified date and time given above, such selected candidates shall forfeit the offer of admission made to them. The Admission Committee will not entertain any request/communication in this regard.

5. LL. B./B. L./Equivalent Degree Marks Sheet and Degree Certificate
6. Transfer Certificate
7. Migration Certificate
8. Conduct Certificate (Not older than six months)
9. CLAT-2026 Admit Card (Signed by the Candidate and Invigilator)
10. Copy of the Certificate issued by Competent Authority in support of candidate's claim for being the Wards of Kashmiri Migrants/Residents of Jammu & Kashmir (as applicable).
11. Digital/Scanned Copy of Fee Payment Receipt containing the amount transferred to HNLU Bank A/C and the Unique Transaction Reference (UTR) Number.
