- The candidates selected for provisional admission are required to pay an amount of **Rs. 2,25,000/- (Rs. Two Lakh Twenty-Five Thousand Only)** and submit the relevant certificates/documents specified below **latest by 05:00 p.m. of 30th May 2026**. - The candidates can make payment through any bank as per the account details given below and submit the digital/scanned copy of Fee Payment Receipt containing the amount of Money Transferred to HNLU Bank A/C and the Unique Transaction Reference (UTR) Number.

- In case any selected candidate fails to pay the fees and/or submit the required certificates/documents by the specified date and time given above, such selected candidates shall forfeit the offer of admission made to them.
