Notification Inviting Application for Admission to B. A. LL. B. (Hons.) and LL. M. Program against the Vacant Seats in Various Categories (Academic Session 2026-27)

Date: 1st June 2026

After completion of the CLAT Consortium conducted admission process on 30th May 2026, HNLU invites direct applications for filling up the remaining vacancies in the B. A. LL. B. (Hons.) and LL. M. Program as per the seat matrix given below.

Available Vacancies in B. A. LL. B. (Hons.) Program

1.	All India Unreserved	14
2.	All India ST	02
3.	CG Domicile Unreserved*	01
4.	CG Domicile ST*	02

Note: * There is 01 seat horizontally reserved for PWD/SAP candidates to be filled from any of the two categories mentioned in Sl. No. 3 and 4. In case of non-availability of PWD/SAP candidates, these seats will be offered to candidates under the respective categories.

Available Vacancies in LL. M. Program

3.	All India ST	01
4.	All India OBC	05

The university seeks to fill-up these vacancies by inviting applications from the respective categories of candidates who have appeared in CLAT-2026 held in December 2025. Interested candidates may therefore apply through **Google Form** by furnishing the required details at the latest by **11:59 p.m. of 7th June 2026** along with a **Non-Refundable Application Fee of Rs. 1000/-** payable through the link: <https://onlinesbi.sbi.bank.in/sbicollect/icollecthome.htm?corpID=5675243>. The **Application Fee Payment Portal link** is also provided on the **Admission 2026** page of the University Website (www.hnlu.ac.in).

The **Google Form** filled in all respects and accompanied with the scanned/digital copy (pdf file) of the **Application Fee Payment Receipt** and other relevant information must be submitted by the scheduled deadline specified above. Applications submitted without the **Fee Payment Receipt** shall not be considered.

Application Procedure:

The interested eligible candidates may directly apply to the University following the *two-step* process mentioned below:

1. First, make online payment of the *Non-Refundable Application Fee of Rs. 1000/-* by clicking on the link: <https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=5675243> and save a soft/digital copy (pdf file) of the *Fee Payment Acknowledgement Receipt* on your desktop; and

2. Second, fill in the (a) *Google Form* by clicking on the link: <https://forms.gle/vtCaFswBNCXpVLb9>, (b) upload a copy of the *Fee Payment Acknowledgement Receipt* saved earlier and then (c) click the *submit* button.

The last date for submission of online application through Google Form is **11:59 pm of 7th June 2026**. After verification and scrutiny of the applications received, the Provisional Merit List will be uploaded on the Admission Page of the university website for information of the applicants to be followed by offer of admission to candidates based on their merit (i.e. CLAT AIR) and available vacancies.

Important Instructions Regarding Successful Submission of Google Form:

Instruction 1: On successful submission of your google form, an *Auto-generated Google Response Sheet* will be received in your registered email inbox immediately after the submission of the Google Form. Please save the digital copy of the *Auto-generated Google Response Sheet* (in pdf format) for future reference as proof of successful submission of your Application Form. Additionally, you will also receive a *Confirmation Email for Submission of Application* from the Admission Committee stating that your application for admission against vacant seats has been successfully submitted.

Instruction 2: If you don't receive the *Auto-generated Google Response Sheet* in your registered email inbox immediately after submission of the Google Form and/or the *Confirmation Email for Submission of Application*, this indicates that your Google Form might not have been submitted successfully. In such a case, you must write to the Admission Committee (admission2026@hnlu.ac.in) attaching a digital copy of the *Fee Payment Receipt* before the deadline for submission of Google Form. No grievances shall be entertained for non-receipt of *Auto-generated Google Response Sheet* and/or the *Confirmation Email for Submission of Application* after the deadline.

Instruction 3: For raising any complaint regarding non-inclusion of one's name in the merit list of applicants (To be published after processing of applications), the candidate must submit (a) the *Auto-generated Google Response Sheet*, (b) the *Fee Payment Receipt*, and (c) *Confirmation Email for Submission of Application* as proofs through an email to the Admission Committee (admission2026@hnlu.ac.in) within 24 hours of the release of the Merit List. No complaints regarding the non-inclusion of names in the merit list shall be entertained unless it is accompanied with the *Auto-generated Google Response Sheet*, *Fee Payment Receipt* and *Confirmation Email for Submission of Application*.

Instruction 4: For technical problems faced, if any, during the submission of the Google Form, due to which a candidate may have failed to submit the Google Form successfully, the candidate must raise the complaint in writing to the Admission Committee (admission2026@hnlu.ac.in) immediately or before the scheduled deadline for submission of Google Form along with a copy of the *Fee Payment Receipt*. No grievances for technical problems shall be entertained unless it is received before the scheduled deadline for submission of Google Form and accompanied by a copy of the *Fee Payment Receipt*.
